

CHURCH SECRETARY'S REPORT

Church Secretary's report for the year ending December 2024

As Church Secretary for 2024, this is my report of the events and activities during that year, celebrating what God has done with us here at London St. and presenting a challenge to prayer and action for the future.

Basingstoke URC registered as a Charity (number 1130801) with the Charity Commission in July 2009. We are known as London Street (Basingstoke) United Reformed Church and we take our structure, governance and management from the Scheme of Union of the URC which is set out in a document known as 'The Manual'. Our objective as a Charity is the advancement of the Christian faith for the benefit of the public in accordance with the Scheme of Union. We achieve that through our activities and facilities offered to the community by our building.

Church Meeting

The Church Meeting of the local church shall consist of those persons who have been admitted to the full privileges and responsibilities of membership of the URC and whose names are included in the membership roll of such local church. (Item 2(1) of the Manual)

Church Meeting of London St. met on 6 occasions during 2024. Our quorum for the year was set at 11, down from 12 in 2023. (Numbers in brackets refer to the number of members in attendance.)

February (34) Having spent the beginning of 2024 recuperating at home, I was absent from the first meeting of the year. The meeting stood in silence as we remembered the passing of Isobel Martin. Members were then informed of a Thanksgiving Service for the life of Eileen Poulter, a former member here at London St.

It was agreed that the practice of taking a retiring collection once a month in support of Commitment for Life and the Town Centre Chaplaincy should be resumed.

The meeting was informed by Revd Josh Thomas that we would have a Fellowship Tour of the building, the first for 6 years, for the

congregation in April; and that London St. would host the Induction Service of the new Wessex Synod Moderator.

Basingstoke and Deane Borough Council are to use our premises as a Polling Station; and the 1st Basingstoke Scouts, due to the closure of Trinity Methodist Church, were to meet at London St. from 19th February.

The meeting concluded with Josh reporting that his appointment as Interim Minister would end on 31st December 2024.

April (38) Tony Patterson gave an update on the electrical work undertaken since the flood in the Concourse; and Josh gave an update about the Wessex Big Day Out.

Following a recent survey of the building by both our fire risk assessor and subsequently endorsed by the Synod, Tony reported that there was a safety risk in continuing to use the front rows of the gallery and steps were required to avoid any incident occurring.

It was agreed that Maxine Perkins should be baptised; and Maxine and Ravindar and Vijaya Biyyani be brought into membership.

Josh spoke about the Away Day for serving elders and the Finance Committee; and also reported that Revd Denis Smith has been welcomed as an organist who has agreed to come and play, normally on the first Sunday of the month.

May (16) At our May meeting I commenced with an update on finances. Grateful for the input provided by Alex Macro who had devoted considerable time to working on the accounts for 2023.

I summarised the lengthy briefing paper on the subject of changes to the formula used in determining the Ministry and Mission contributions for churches in the Wessex Synod. I concluded that the new formula figure for London St. resulted in a slightly higher contribution but it would be for the Elders to decide on the level of contribution which would be offered for 2025. Staying with financial matters, I reported that the Department for Culture, Media and Sport were offering grants under their Listed Places of Worship Grant Scheme to cover the VAT on repairs over £1,000 to Listed Buildings used as places of worship. Having assembled the requisite information for the completion of the application form, if successful, approximately £8,500 worth of VAT would be recovered.

With a proposal coming from Matthew Dumbleton as editor of Focus, the meeting agreed to purchase material suitable for children from the UK's leading resource for church magazines, news-sheets, and websites, "Parish Pump Ltd.", for inclusion in Focus.

I then turned my attention to our Constitution by reporting a proposed change to Clause 21(c) concerning the election of Elders. The proposal was posted on the Church noticeboard and brought to the September Church Meeting for decision.

July (31) I once again started the meeting by reporting on financial matters. Our application for a VAT refund on electrical work was approved by the Department for Culture, Media and Sport and a refund of £8,515.81 had been received. Alex was thanked for drawing the attention of the Finance Committee to the possibility of such a refund.

Following research undertaken by Alison Jamieson, I reported that as a consequence of a generous donation from a member of the congregation an additional 108 mugs and 27 dessert bowls were purchased. Thank you Alison.

Following research undertaken by Peter Burrows, I reported that there were funds available that the church as a charity could apply for and Peter had agreed to be the key person in seeking out and applying for grants. Thank you Peter.

I invited the meeting to recommend the following into membership: Nicola Hamilton on transfer from Fleet; Peter Burrows on transfer from the Church of England; Nicola Walden on profession of faith; Eric Elong Ebolo and Emelda Woutou Njiki on transfer from the Presbyterian Church in Belgium.; and at the same time the baptism of Nicola Walden and Aiden and Ava, (children of Eric and Emelda) would take place.

With the resignation of Jenny McCloy and Carol Scott as Junior Church Leaders, Liz Foster was appointed as a Church Officer to the position of Junior Church Leader to take effect from 1st September 2024. Jenny and Carol were thanked for their work and Liz for taking on this important role.

I finished by reporting on the closure of the gallery following a request by our insurance company that simply putting in place warning notices was considered inadequate. Given the time it would take to resolve the matter, Josh and I made the decision to close the gallery to all users.

September (29) Tony reported on the work he had done to prevent use of the first row of the gallery. The insurers accepted this solution and the gallery reopened. We are grateful to Tony for his solution as it had saved the church a considerable amount of money.

Thank you to Maggie Morgans for hosting the garden party and to all who helped with catering, organising furniture and other tasks related to the party.

The change to our Constitution was agreed with no objections.

Julia Burrows as Chair of the Finance Committee, reported on a review of the church's utility suppliers undertaken by the Finance Committee. Following this electricity had been switched from EDF to British Gas and gas from Utility Warehouse also to British Gas. The new tariffs represented a considerable reduction on the previous ones. In addition, a refund for over-payment had been obtained from Utility Warehouse, and an application for a refund of overpaid VAT on electricity over four years had been made. Thank you Julia.

Margaret Carrick Smith and I had visited Woking URC to learn more about their solar panel installation. In the light of our findings, the Elders had agreed to ask the Synod Property Officer to arrange for a feasibility study, which could be paid for by the Synod, in order to determine what would be possible at London St., the likely costs and payback.

Having referred to the crisis in Myanmar prior to the service on 25th August, it was agreed that we would have a retiring collection on Sunday 20th October when the Moderator of the Wessex Synod, the Revd Michael Hopkins would be leading worship. It was agreed that London St. would match donations received from the congregation in the retiring collection, subject to a maximum of £500.

On the following Sunday, 27th October, the service will be led by Revd

Mike Burrell and will include the baptism of Harley James Honeyball-Todd, son of Samantha and Ray, and grandson of May Honeyball.

Josh spoke about the Tearfund big quiz evening on Saturday 16th November at 7pm he would be hosting for both London St. and Petersfield URCs.

Tony and I had attended the induction of Revd Kay Blackwell (a former Minister here at London St.) as Special Category Minister at St. Cuthbert's URC, Holy Island, which took place on Saturday 31st August at Wooler URC. Kay and Andrew Blackwell were both very well and had sent their greetings to everyone at London St. They would be delighted to see anyone from the church who visited Holy Island. Kay had mentioned that if a small group from the church wished, they could go to Holy Island to stay; there was accommodation and she would lead a study day or days.

I finished the meeting by reporting that for health reasons I would be stepping down as Church Secretary at the end of 2024. Gill Miller had volunteered to take the role, with this appointment being brought to the next Church Meeting for a decision.

November (41) As always, the November meeting focused on the election of Elders. All those standing had been validly elected to serve from January 2025 to December 2027: Margaret Carrick Smith, Joyce Cook, Matthew Dumbleton, Liz Foster, Jenny McCloy, Maggie Morgans and Tony Patterson.

Thanks were given to Jenny McCloy who was willing once again to continue as the church's Synod representative for 2025.

In discussing financial matters, I spoke of the "headlines" of the 2023 Accounts. During 2023 the church had been fortunate to receive a legacy of £357,878. Whilst a blessing I stressed that it did not mean our finances were sound because the reality was the opposite. Without the legacy, 2023 showed a deficit of just over £56,000. The deficit in 2022 was £11,000. The cost of running the church increased each year, and the deficits in the accounts showed that this was not matched by a similar increase in income. If nothing was done to rectify this, and the deficits were covered by the legacy, then it was clear that in 6 years or sooner there would be no money left. In response to this, the Trustees would explore ways of decreasing expenditure, and also ways of increasing income.

Thanks were expressed to May Honeyball who had taken the lead in revising the church's Safeguarding Policy.

Church Officers are appointed by Church Meeting, following a recommendation from the Elders. Whilst this normally took place at the Annual Church Meeting in March or April, as I intended to step down as Church Secretary at the end of December, I had sought the approval of the Elders in October to bring to Church Meeting the name of Gill Miller to take on this role. All Elders had indicated their agreement to this proposal. Members were invited to appoint Gill Miller as Church Secretary effective from 1st January 2025. This was carried.

Church Members

As at 1st January 2024, our membership stood at 72. We gained 8 by welcoming Maxine Perkins, Ravindar Biyyani, Vijaya Biyyani, Nicola Hamilton, Peter Burrows, Nicola Walden, Eric Elong Ebolo and Emelda Woutou Njiki into membership, but over the course of 2024 we lost our dear friend Isobel Martin. In addition Rosemary Martin moved away from Basingstoke. Taken together with the movement of some members to our associate list, the number of active members by 31st December 2024 increased to 77.

Elders' Meeting

The Elders' Meeting of the local church shall consist of the minister and the elders elected by the Church Meeting. (Item 2(2) of the Manual)

Elders' Meeting of London St. comprised of 10 serving elders in addition to the church officers and our Interim Minister. They met on 11 occasions during 2024. Attendance: Owen Collins (Church Secretary) (10), Karen Bell (Church Treasurer) (0), Leng Ayland (9), Margaret Carrick Smith (11), Joyce Cook (8), Alison Jamieson (11), Ian McCloy (9), Jenny McCloy (10), Gill Miller (8), Kengjisu Moavu (3), Tony Patterson (10), and Ian Scott (9). (Numbers in brackets refer to the number of meetings attended from 11.) January The elders considered a number of items as always. They included a review of the events over Advent and Christmas; a review of Communion offerings; the enhancement of the new fire alarm system and emergency lighting; the need for additional helpers in Junior Church; new lettings; the appointment of a Finance Committee for 2024 and their terms of reference; and to hold a Fellowship Tour of the church premises.

February In February the meeting commenced with a time of silence in remembrance of Isobel Martin. The elders considered the arrangements for the Fellowship Tour in April; and the need to consider a replacement for Karen Bell as Church Treasurer. With the increased cost of renewing the contract for the main church printer, alternatives were considered; and the elders were reminded of the need for all to attend a Safeguarding Course.

March The bulk of the meeting centred around our finances. This included a discussion on the paper from the Wessex Synod on the review of changes to the formula used in determining the Ministry and Mission contributions. The arrangements for the Induction Service of our new Moderator were finalised.

April In April Josh updated the meeting on arrangements for the Away Day for elders and members of the Finance Committee; and the Wessex Big Day Out. An agreement was reached on switching our contract for a printer to a new provider. Once again the bulk of the meeting focused on the need for a new Treasurer and the Accounts for 2023.

May Elders' Meeting considered a proposal brought by Margaret to amend Clause 21(c). The changes were agreed but would need to go Church Meeting for approval. I brought two proposals to the meeting from Matthew Dumbleton. From a safeguarding perspective he proposed stripping out the contact details and names of children that appear in Focus when a copy is published on the website; and for the church to purchase a resource called Parish Pump Ltd which is the UK's leading resource for church magazines, news-sheets, and websites, particularly for children. Training on the use of the fire extinguishers and the appointment of fire safety officers was discussed with no consensus reached. June Work started on revising a number of policies. Alison Jamieson reported that new crockery had been purchased for the kitchen.

July Consideration was given to finding an alternative utility supplier. Arrangements were made to deep clean the kitchen during the summer break and also to clean the dais carpet. Arrangements for the Elders' election were discussed as well as events and services for Harvest and then Advent and Christmas.

September Having received no comments from the congregation, it was agreed that the proposal to amend Clause 21(c) of our Constitution would now be put to the September Church Meeting for approval. A discussion took place centred around the meeting that Margaret and I had with Woking URC regarding the installation of solar panels. It was agreed to hold a retiring collection on Sunday 20th October for the Christians in Myanmar. Tony presented the Health and Safety Policy for approval. I reported that once again the Night Light Winter Shelter would be running between the beginning of December and the end of February. It was agreed that we could provide the requisite accommodation on a Thursday evening for the three months but in doing so a charge should be made to contribute to, or cover, the cost of utilities.

October October saw once again financial affairs taking centre stage. The 2023 Accounts were agreed just requiring Karen Bell's signature prior to submission to the Charity Commission. With the 2023 Accounts having been completed and signed off, it was agreed that Keng would now take over as Church Treasurer. Arrangements for the Elders' Election were finalised.

November I outlined a problem with the organ brought to my attention by Alex. Occasionally when switched on it would trip the power supply into the sanctuary. The circuit breakers, fitted under the gallery stairs, were all replaced by GU Solutions after we commissioned them to do a lot of work after the flood. We had GU Solutions come in twice to investigate. The issue was resolved at no additional cost to the church. Two policies, one for Safeguarding and one for Food Hygiene were agreed.

December Elders in waiting recently elected: Matthew Dumbleton; Liz Foster and Maggie Morgans were invited to join the meeting. Tony reported that the six-monthly service of the fire alarm system had been completed and we had been issued with the appropriate certification. Rotas and guidance notes were provided to the Elders as well as a schedule for Elders' Meetings and Church Meetings in 2025.

Matters pertaining to Gift Aid were discussed and the email account for the Church Treasurer had been transferred to Keng with the account for the Church Secretary awaiting transfer to Gill in the last week of December. Josh was thanked for his contribution to London St. as Interim Minister and myself as Church Secretary.

Trustees

The serving Elders at London St. are appointed as Trustees of the London Street (Basingstoke) United Reformed Church Charity. The role, responsibilities and training of Trustees is dictated by the Charity Commission:

Charity Trustees are responsible for the general control and management of the administration of a Charity. Trustees have and must accept ultimate responsibility for directing the affairs of a Charity, and ensuring that it is solvent, well run, and meeting the needs to which it has been set up.

The Trustees here at London St. have paid due regard to the guidance issued by the Charity Commission on public benefit.

The Basis of Union states that the functions of Church Meeting and Elders' Meeting (Trustees) (as Interim Minister Revd Josh Thomas is not considered as a Trustee) collectively share the duties and responsibilities outlined for the Elders' Meeting along with accepting the ultimate responsibility for directing the affairs of the Charity as laid down by the Charity Commission. The general control and management of the administration of the Charity is further exercised by representative Elders being members of the Church's' four main committees:

•Finance – managing all the day to day financial responsibilities and the preparation of the accounts. Thank you to Julia Burrows as Chair and Alex Macro undertaking a lot of the work normally undertaken by Karen Bell during her absence on health grounds; •Property – managing the maintenance of the Church (the Church building is vested in The United Reformed Church (Wessex) Trust Limited as trustees and held for the benefit of London St. in accordance with the trusts applicable to URC properties). Thank you to Tony Patterson in particular as well as Joy Williams, Rob Williams, Chris Ayland and David Waller;

•Children and Youth Work – instituting and overseeing the work with children and young people. Thank you to Carol Scott and Jenny McCloy (to August) and Liz Foster (from September) as Junior Church leaders, and to Gill Craft as leader of the 8th Basingstoke Scouts;

•Mission – ensuring that the Church demonstrates its concern for the local community and the world. Thank you to Alison Jamieson who chairs the World Mission Group.

Not all serving Elders have undergone formal training for their duties specifically as Trustees, other than to acquaint themselves with their responsibilities when required to do so, for example in connection with the safeguarding of children and vulnerable adults, and health and safety generally. Those nominated to serve as Elders are now required to declare their intention to undertake such training as dictated by the General Assembly Executive and it is incumbent on those already serving to do the same.

Disclosure and Barring Service, Safeguarding, Health and Safety, and GDPR

On-line Disclosure and Barring Service is administered by myself and Joy Williams for those at London St. who will work with children, young persons and vulnerable adults. All serving Elders are required to be DBS checked and in accordance with policy set by the URC, every 5 years.

In relation to safeguarding, all Trustees are required to undertake formal safeguarding training every 3 years and some attended courses during the year via Zoom. There were no safeguarding incidents to report to the Charity Commission in 2024.

The Safeguarding Policy drafted by the URC has been adopted by London St. with modifications implemented to reflect the nature of our work with children, young people and vulnerable adults. It's important that we provide a caring and safe environment, not just on a Sunday morning for our church family, but during the week too with all those we meet at activities such as Memory Tree and of course during pastoral visits. This structured approach helps us to achieve that. Thank you to May Honeyball, Joyce Cook and more recently Alastair Cox as our safeguarding co-ordinators.

Through Elders' Meeting, as Church Secretary I ensure that the Church complies with GDPR (General Data Protection Regulation).

An overview of the Church's life and work during the year

Worship, prayer and study

Our average attendance remains fairly constant at 60. We are grateful to all our visiting preachers, including Peter Bentall and Joy Williams our two lay preachers. Thank you to Alison Jamieson and Joy Williams for organising and running Take Time meditation and bible study on Zoom. Thank you also to Josh as our Interim Minister and to Jenny McCloy and Alison Jamieson in putting together the preaching rota for Sunday worship; to Tony Patterson, John Carrick Smith and Matthew Dumbleton for the PowerPoint on a Sunday morning and Alex Macro in organising our audio rota.

Children and Young People

Thank you to Carol Scott, Jenny McCloy and Liz Foster who organise worship for Junior Church and to the adults who support them. Thank you to Gill Craft and Annmarie Smith Browne for leading the 8th Basingstoke Scouts.

Archivist

We have yet to find a replacement for Jean Holton as Archivist, but thank you to John Hollands who has been sorting out the archives for the last 12 months.

Community Work

We continued to serve the community here in Basingstoke. During the week on a Monday, Tuesday and Thursday lunch times, we ran our hot food table utilizing food from the supermarkets and serving it to those in need who came to the table. On a Saturday at lunchtime we open our food table to distribute food from the supermarkets. Thank you to Carol Tooke our Kitchen Supervisor and the volunteers who help in the kitchen; to Joy Williams who organises the rota of volunteers for the table and those who help; to Alison Jamieson, Karen Bell and Leng Ayland and volunteers for helping on a Saturday.

The Memory Tree Social Club meets every week on a Wednesday in the Hook Room from 10.30am to 12.00pm. It is an opportunity for people diagnosed with Alzheimer's and other types of dementia and their carers, to relax, enjoy themselves and make new friends. We have a wonderful team of volunteers who look after our visitors with love, kindness and laughter. We have an average of 25-30 visitors every week, and their feedback is that we provide a unique and special place where they can relax and talk to other carers and people with dementia. Thank you to Jenny and Ian McCloy, Ted Martin, Joyce Cook and the volunteers who bake cakes for Memory Tree. We remember of course Isobel Martin who served regularly as a volunteer for many years.

The Craft Club met every Monday morning in the Concourse. The Club grew out of the interest expressed by a few of the carers who come to Memory Tree. They were interested in learning a new craft and it was easier to do this at a dedicated time and place rather than taking time away from the normal activities on a Wednesday morning at the Memory Tree. Isobel Martin was the driving force behind the group which began in September 2015 and she is missed. The members cover a wide spectrum of crafts and are happy to share news, patterns and skills. It is interesting to note that the Club continues to welcome people who don't have any other connection with London St.. Thank you to Carol Scott for running the Club.

Pastoral Care

Our objective as a Charity cannot be achieved if we don't look after one another. Knowing Jesus and making Jesus known is perhaps a key foundation stone of our church family. By His love and care for us we reach out to one another and in the wider community through our words and actions. It may be in a practical way by shopping or giving a lift for a medical appointment or to worship on a Sunday. It may be by listening or encouraging with a comforting word, smile or hug or praying for one another. We are thankful to God for His love shown to so many during the last 12 months.

Premises

The building continued to be maintained, and lettings managed.

My prolonged absence from Church continued for the first two months of 2024. Prior to my absence I was very much taking the lead in coordinating what needed to be done in repairing the damage as a consequence of the flood we had in June 2023. I'd like to convey my thanks to Joy, Margaret and Gill for helping in my absence but my biggest thanks go to Tony who has done a considerable amount of work in contacting contractors and co-ordinating what needed to be done and drafting requisite paperwork.

As for the day to day maintenance, thank you once again to Joy, Rob, Chris, David and Tony; to Lou Waller and Leng Ayland for cleaning the premises; and to Tony once for overseeing the lettings.

I'd like to return briefly to the works undertaken following the flood. The financial cost of putting right the damage caused by the flood has been huge. I'm sure that Keng as our Church Treasurer will cover this in some detail when he presents his report, but if we are to keep the bulk of the legacy we received in 2023 for future mission and maintenance we must consider ways of raising additional funds. We simply cannot sustain our spend at current rates with or without the legacy.

Having spent the last four months of 2023 and the beginning of 2024 either in hospital or recuperating at home, I would like to express my thanks to the congregation for your love and prayers and practical support. Thank you in particular to Alison and Jenny for taking on the task of securing preachers and musicians for Sunday Worship; and to Tony who has done a considerable amount of work, particularly in maintaining the momentum of ensuring that work proceeds on projects relating to the damage caused by the flood. I am particularity grateful to Margaret for taking on the role of Church Secretary and also to Josh for coordinating everything.

Looking back over the last ten years as Church Secretary, when asked to consider this role I had a couple of meetings with Revd Kay Blackwell before accepting the call to serve. I felt called to focus on the 'church' aspects of the job, in may ways a continuation of the work that Joy had done. However, I was well aware that no two people will work in the same way. Six months into the job I began to feel more at ease with my responsibilities in serving the Lord within the community, the wider church and of course London St. as I slipped into my 'secretarial' role.

That being said, I never really had a clearly defined role and certainly was never given a job specification. After lockdown, Kay was called to a new pastorate and my focus changed. I found myself taking on much more of a 'secretarial' role - as church administrator, pulpit supply officer, and anything really that needed to be done. It ended up being

virtually a full time job!

When taking on the role, I brought together my life skills as a career Civil Servant, school governor, Justice of the Peace, Chair of Pages Charity, father, grandfather and husband. And of course I had learnt a lot from my late wife Ann, in her role as a Non-Stipendiary Minister here in Basingstoke. In doing so I trust that over the last ten years, as a congregation you have found this beneficial in supporting London St.

Normally a church secretary will work alongside the Minister. For the last 4 years, maybe more if you consider the periods we were in lockdown, that hasn't happened and I have very much been the primary contact here at London St. I have often dealt with matters that would have normally been dealt with by the Minister. Having said that it has been a joy and blessing to have the support of Revd Josh Thomas as our Interim Minister for the last two years. Thank you Josh.

Yes, I have been frustrated and challenged on a number of occasions. And yes, I have made mistakes. But looking back, prayer and a desire to do what is right for this Church have supported me. Overall I have enjoyed my time as Church Secretary, and despite the heavy burden at times, I will miss it.

Gill Miller now takes on the mantle of Church Secretary. As well as offering practical support if able to do so, please remember Gill in your prayers. Thank you Gill for accepting the call to take on this important role.

I conclude my report with a prayer:

Thank you Lord for our church here at London Street, and for those who have worshipped in it over the years and for those who serve it today. May we continue to know your presence here Lord and open our hearts and minds to all that you have given us and may you in return graciously accept all that we have to offer you. 


